All entrants must follow and agree to the following terms and conditions:

1. Be a resident of Wading River or Shoreham.
 2. Be a student in grades kindergarten through grade 5.
 3. Submit a photograph (3”X5” or 4”X6”) that will be displayed at local Chamber of Commerce member businesses and in local newspapers. All photographs and publicity therefrom are the property of the Wading River-Shoreham Chamber of Commerce and cannot be returned.
 4. Submit the official entry and permission form signed by parent or guardian.
 5. Voting on entries will be done by community residents, and placed in ballot boxes provided for that purpose. Voting entries will be reviewed and tabulated by the Chamber of Commerce “Little Miss and Mr. Duck Pond Day” Committee.
- All entries must be submitted by April 18. Late entries will not be accepted. Winners will be notified by May 1. In the event of a tie, the decision of the Chamber of Commerce “Little Miss and Mr. Duck Pond Day” Committee will be final.
6. Agree to ride in a car or float in the Duck Pond Day Parade.
